**FOR FIFTH STRAIGHT YEAR, REFINITIV RANKS TIBER HUDSON NO. 1  
UNDERWRITER'S AND BOND PURCHASER'S COUNSEL IN THE U.S.  
FOR MULTI-FAMILY BOND ISSUES**

WASHINGTON, D.C. — For the fifth year in a row, law firm Tiber Hudson LLC has been named the No. 1 underwriter's and bond purchaser's counsel in the nation by Refinitiv, based on the number of multi-family bond issues closed in 2022. Tiber Hudson has topped this list every year since its first full year of operation in 2018.

According to Refinitiv's year-end multi-family market analysis for 2022, Tiber Hudson ranked first nationally in the role of underwriter's counsel and bond purchaser's counsel for number of multi-family bond issues closed, serving families in 36 states. The aggregate principal amount of the issues totaled almost \$5 billion. These bond issues contributed to the construction or rehabilitation of more than 33,000 affordable housing units this past year.
